praying to relax the condition imposed on the petitioners previously.

ORDER

Heard both sides. Perused the petition.

Offence u/s 294(b), 353, 352 and 506(ii) of IPC.

The petitioners were granted anticipatory bail by the Principal Sessions Court, Kanniyakumari at Nagercoil on 23.04.2024 in CrI.M.P.No.2262/2024 with condition that the petitioners should appear and sign before the respondent Police daily at 10.00 A.M. until further orders.

The learned counsel for the petitioners submitted that the petitioners have been complying the condition regularly from 26.04.2024 and due to the above said condition, they could not do their daily works and prayed that the condition may be relaxed.

The learned Public Prosecutor opposed the application and submitted that the petitioners have been complying the condition from 26.04.2024 and the investigation of the case is not yet over.

Considering the nature of the offences alleged to have been committed by the petitioners/accused and also considering the duration of compliance of condition and the facts and circumstances of the case, this court is inclined to modify the condition.

In the result, condition is modified that the petitioners shall appear and sign before the respondent police weekly once i.e. on every Monday at 10.00 A.M. until further orders and accordingly this petition is partly allowed.
