Subsequently, the condition was modified on 29.02.2024 in Crl.M.P. No.1347/2024 with condition that the petitioners should appear and sign before the respondent police weekly once i.e. on every Monday

twice at 10.00 A.M. and 5.00 P.M. until further orders.

The learned counsel for the petitioners submitted that the petitioners

have been complying the modified condition regularly from 04.03.2024 and they did

not comply the condition on 04.04.2024 and 29.04.2024 and due to crucial work of

construction, they are unable to comply the condition and prayed that the non

compliance of condition imposed on the petitioners may be condoned.

The learned Public Prosecutor submitted that the petitioners have been

complying the condition from 04.03.2024, but they did not comply the condition on

08.04.2024 and 29.04.2024.

Considering the submission made by the learned counsel for the

petitioners/ accused, this court is inclined to condone the non compliance of

condition imposed on the petitioners from 08.04.2024 and 29.04.2024 is condoned.

In the result, non compliance of condition imposed on the petitioners in

Crl.M.P.No.1347/2024 dated 29.02.2024 is condoned and accordingly this petition is

allowed.
