The learned Public Prosecutor opposed the application submitted that the petitioners have been complying the condition from 01.05.2024 and the investigation of the case is not yet over.

Considering the nature of the offences alleged to have been committed by the petitioners/accused and also considering the duration of compliance of condition and the stage of investigation, this court is inclined to modify the condition.

In the result, condition is modified that the petitioners shall appear and sign before the respondent police weekly once i.e. on every Monday at 10.00 A.M. until further orders and accordingly this petition is partly allowed.
