This petition is filed by Advocate Thiru. M.Beslin Jagadheese, praying to condone the non compliance of the condition imposed on the petitioners in Crl.M.P.No.2275/2024 dated 24.04.2024.

ORDER

Heard both sides. Perused the petition.

Offences u/s 447, 294(b), 427 and 506(ii) of IPC.

The petitioners were granted anticipatory bail by the Principal Sessions court, Nagercoil on 24.04.2024 in Crl.M.P.No.2275/2024 with condition that the petitioners should appear and sign before the respondent police daily at 10.00 A.M.

until further orders.

The learned counsel for the petitioners submitted that the petitioners have been complying the condition from 01.05.2024 and the 1st accused who is the brother of the 1st petitioner and son of the 2nd petitioner died, due to road accident on 07.05.2024 and therefore the petitioners were unable to comply the condition from 08.05.2024 to 17.05.2024 and thereafter they have been complying the condition from 18.05.2024 and prayed that the non-compliance may be condoned.

The learned Public Prosecutor opposed the application and submitted that the petitioners have been complying the condition from 02.05.2024, except on 08.05.2024 to 17.05.2024 and the investigation of the case is not yet over.

Considering the submission made by the learned counsel for the petitioners/accused and also considering the duration of compliance of condition, this court is inclined to condone the non compliance of condition imposed on the petitioners from 08.05.2024 to 17.05.2024.

In the result, non compliance of condition imposed on the petitioners from 08.05.2024 to 17.05.2024 is condoned and accordingly this petition is allowed.
