No.2347/2024 with condition that the petitioner should appear and sign before the Sub Inspector of Police, Kottar Police Station daily at 6.00 P.M. until further orders.

The learned counsel for the petitioner submitted that the petitioner has been complying the modified condition regularly from 27.04.2024 and the petitioner is a student studying Government Industrial Training Institute at Konam and due to the above said condition, the petitioner is unable to attend the college regularly and prayed that the condition may be relaxed.

The learned Public Prosecutor submitted that the petitioner has been complying the condition from 28.04.2024.

Considering the nature of the offences alleged to have been committed by the petitioner/accused and also considering the duration of compliance of condition, this court is inclined to relax the condition.

In the result, condition is totally relaxed and accordingly this petition is allowed.
