NOTIFICATION

As per the letter cited preamble at Sr No.2, it is stated that Okhapura (Antroli) Village came under the various jurisdiction as shown below:

Jurisdiction of Police Station is at Dantiwada, Jurisdiction of Court is at Amirgadh while Revenue Jurisdiction is at Palanpur.

As per the letter cited preamble at Sr. No. 3, letter from Mamlatdar Palanpur (Rural), it is stated that the revenue jurisdiction of the Okhapura (Antroli) Village is at Palanpur. Moreover, The Legal Department Notification No. GK/18/2007/CCA/1082/2157/D (Part-I), Dated 18.09.2007 as cited at Preamble Sr. No.1, new Court of Amirgadh has been established with effect from 23.09.2007 and as per the said notification, local limits of the ordinary jurisdiction of the court of a civil judge Amirgadh, shall consist area of villages of Amirgadh taluka and the local limits of Amirgadh taluka shall be excluded from the jurisdiction of the court of civil Judge, Palanpur. Though Okhapura (Antroli) village, having the revenue jurisdiction of court is Palanpur taluka, the said jurisdiction of the civil court for Okhapura (Antroli) village is running in Amirgadh Court. Hence it is quite necessary to make a change in respect of Jurisdiction of the Okhapura (Antroli) village as per its revenue jurisdiction. Hence the undersigned is pleased to notify the existing jurisdiction of **Okhapura (Antroli)** village from the jurisdiction of the Court of Civil Judge Amirgadh to the **Court of Principal Senior Civil Judge Palanpur** with effect from **01.10.2023**.
