



Functions of the Committee :-

- (1) The Monitoring Committee shall operate in accordance with the guidelines and instructions outlined in Points No.9(a) to 9(c) in the Order cited in the preamble at the Serial No.(1).

- (2) The Secretary of the District Legal Services Authority shall be the convener of the monitoring committee.
- (3) The Committee shall meet at least once in every two months.
- (4) The Committee shall monitor the implementation of the Scheme cited in the preamble at the Serial No.(3) in the District Palanpur for the Compliance of the directions passed by the Hon'ble Apex Court vide Order cited in the preamble at Serial No.(1).
- (5) The Secretary shall submit a quarterly report on the functioning of the monitoring committee to the Hon'ble Member Secretary, Gujarat State Legal Services Authority, Ahmedabad.
- (6) The Monitoring Committee shall observe the claim applications that are received in this regard and shall monitor the implementation of the Compensation to Victims of Hit and Run Motor Accident Scheme, 2022.
