In continuation of this office Notice dated 02.01.2025, communicated vide Memo no.-19-64/Admn. Dated 02.01.2025 in view of Rule 15A of "The Bihar Civil Court Officers and Staff Rules, 2022" whereby willingness were invited from all the eligible Class-III & IV Staff of Civil Courts, Bihar, who have been superannuated and not completed the age of 65 years for consideration of their re-employment in their respective cadre is hereby extended till 14.02.2025 who fullfills the following criteria: -

- (i) The applicant must be residing within the jurisdiction of Patna Judgeship,
- (ii) The applicant desires to be re-employed in Patna Judgeship,
- (iii) The applicant not re-employed in their respective Judgeship and
- (iv) The applicant not applied for re-employment in their respective Judgeship.

The applicants must submit the followings along-with their respective willingness: -


- (i) Copy of Pension Payment Order,
- (ii) Copy of Aadhar Card and Pan Card,
- (iii) Copy of Residential proof of Patna,
- (iv) An affidavit regarding details of Departmental proceeding initiated against applicant, not applied for Re-employment or not re-employed in their respective Judgeship & details of Criminal Case, if any.
- (v) No Objection Certificate from respective Judgeship regarding submitting application for re-employment in Patna Judgeship.
- (vi) Medical Fitness Certificate issued by Civil Surgeon or Chief Medical Officer.

The willingness alongwith all relevant documents as mentioned above must reach to the office of the undersigned by 14.02.2025 till 05:00 PM.

All the Judge-in-Charge of Patna Judgeship are directed to publish this notice on the Notice Board of their respective Civil Court.

The System Officer, Patna Sadar is directed to publish this notice on the website of Civil Courts, Patna for information to all concerned.
