

PUBLIC NOTICE

It is with reference to the advertisement for the 18 posts of Stenographer Grade-III (ad hoc) in Ambala Sessions Division, published in English Newspaper 'The Hindu' and Hindi Newspaper 'Dainik Bhaskar' on 17.08.2024.

It is to inform that the shorthand test for the posts of Stenographer Grade-III (ad hoc) will be held on 07.09.2024 (Saturday) from 1:30 P.M. onwards and on 08.09.2024 (Sunday) from 10:00 A.M. onwards in the Judicial Courts Complex, Ambala City.

Note :-

1. The eligible candidates mentioned in **list-1** from Serial No. 1 to 300 are required to report for shorthand test for the posts of Stenographer Grade-III (ad hoc) on **07.09.2024 (Saturday)** at **10:00 A.M. sharp** and the candidates from Serial No. 301 to 825 are required to report for the shorthand test on **08.09.2024 (Sunday)** at **9:00 A.M. sharp** in the Judicial Courts Complex, Ambala City. Any candidate reporting at the venue after the scheduled time shall not be allowed to appear in the shorthand test.
2. The candidature of the candidates for the post of Stenographer Grade-III (ad hoc) mentioned in **list-2** has been rejected as the applications have either been received after last date of receipt of applications i.e 28.08.2024 or do not meet the required qualification or have been made for the posts not advertised.
3. The short hand test shall comprise of dictation and typing of the transcription on the Computer.
4. The candidates are directed to bring only pencil, pen and valid identity proof, failing which, they shall not be allowed to appear in the shorthand test.
5. No mobile phone or any other electronic device shall be allowed in the examination room.
6. The benefit of reservation to the candidate shall be governed according to the instructions of Haryana Government on the subject and if a particular caste is not included in the list, he/she shall be treated in the general category for all purposes.
7. The candidates are required to bring their original documents along with ID proof, age proof, Caste Certificate at the time of Computer Proficiency Test, failing which they shall not be allowed to appear for the test.
8. The candidates are required to remove the discrepancies, if any, (i.e. ID proof, Photo, other relevant certificates, attested documents, etc.) mentioned in the remarks column at the time of Computer Proficiency Test to be conducted after the shorthand test, for which the schedule shall be intimated separately on the official website of Ambala Sessions Division i.e. www.ambala.dcourts.gov.in.
9. In case any discrepancy is noticed at the time of Computer Proficiency Test, the candidature of the candidate is liable to be rejected.
