In case any Duty Magistrate intends to leave the station on any holiday/Sunday etc., he/she will make necessary arrangements for duty work during his/her absence with other Duty Magistrate under intimation to the undersigned and the Learned Sessions Judge, Ambala. He/She will be responsible to intimate all the concerned SHO of the police stations falling within the jurisdiction of Sessions Division, Ambala.

3. The Duty Magistrate shall also perform protocol duty during his/her duty period under the supervision of undersigned/ Ld. ACJM, Ambala.

4. It is further clarified that the duty period for a particular day shall be up-to beginning of the court hours on the next working day.

5. It is further ordered that in case any Magistrate is not attending his court on account of being busy in performing duties like inquest proceedings etc. the work of urgent nature shall be performed by concerned Duty Magistrate or next Duty Magistrate as the case may be.
