Technical Asstt.	Graduate holding a BCA Degree or any other equivalent degree
Stenographer	Graduate holding one year diploma course in stenography
Office Asstt.	Graduate holding one year computer course
Peon	Minimum Class VIII Standard; and those who have passed H.S.L.C. or above shall be ineligible to apply.
Driver	1. Minimum Class VIII Standard. 2. Candidate must hold valid Professional driving license to drive LMV/ four wheeler vehicles for not less than last 5 years from competent authority.

Relaxation of age will be admissible as per existing rules of the Government of Assam.

1. The filled up "Application Form" along with recent two copies of passport photograph duly signed by the candidate on the reverse side, all copies of self attested documents like age proof certificate, educational qualification

certificate, employment exchange registration certificate for the State of Assam, driving license (in case of apply for the post of driver), experience certificate if any, forwarding documents in case of apply through proper channel shall be sent addressing to the District and Sessions Judge, Goalpara.

2. The candidates who are already in the Govt. service shall apply through proper channel.

1. The application form must be fill –up in capital letter and the post applied for must be written in capital letter on top of the envelop within inverted comma(e.g. " FOR THE POST OF.....")
2. The application form should reach the Office of the undersigned within office hour i.e. by 5 pm on the last date mentioned above. No application will be accepted or received after the last date of submission of application.
3. Candidates must have registered their names in the employment exchange and the registration numbers along with date must be mentioned in their applications

The list of eligible candidate for interview/written test/other test shall be uploaded in the official website of Goalpara District Judiciary(<https://goalparadistjudiciary.gov.in>) in due course of time. No individual call letter will be sent to eligible candidate. The date and place of Interview/other test/Viva Voce shall be notified in the above mentioned Official Website and in the Office Notice Board in due course of time.
5. The application form which is incomplete in any respect is liable to be rejected summarily, unless otherwise decided by the Selection Board.
