Applications are invited in Standard Form from intending candidates for filling up of the following vacant posts under the Establishment of The Chief Judicial Magistrate, Goalpara, Assam as shown below:

Terms and conditions:

1. Candidates must be an Indian Citizen as per the Constitution of India.
2. Candidate should not be less than 18 years and should not be more than 40 years as of 01.01.2024 (5 years relaxation for SC/ST candidates, 3 years relaxation for OBC/MOBC candidates, 2 years relaxation for Ex- Servicemen and 10 years relaxation for PWD candidates)
3. Candidates must have registered their names in the Employment Exchange and the Registration numbers along with date must be mentioned in their applications.
4. Candidates who are already in Govt. Service will have to apply through proper channel along with the copy of the respective Service Book and NOC from his/her employer.
5. The applications with self attested photocopies of all relevant testimonials regarding Educational Qualification, Experience Certificate (wherever applicable), Caste, Age proof, Employment Exchange Registration Card ,along with 5 (five) recent (taken after 01-01-2024) passport size photographs duly signed by the candidate on the reverse side **along with an**

**undertaking that the candidate has not passed HSSLC examination** should reach the office of The Chief Judicial Magistrate, Goalpara within 20 days from the date of publishing of the advertisement.

6. Candidate must provide their email address and mobile phone numbers in the application form without fail.

7. Candidate must indicate prominently the name of posts applied for on the top of the envelope containing the application.

8. The last date of receipt of application will be 20 days from the date of the publication of the advertisement **by post or through the drop box provided within the court complex**. No application will be entertained after the last date. The appointing authority shall not be responsible under any circumstances for any postal delay.

9. Applicant must be Class VIII passed from a recognized school but below HSSLC (A candidate who has passed HSSLC shall be ineligible for the posts)

10. Eligible candidates for the post of Peon will have viva-voce test only.

11. No individual call letters/ admit cards shall be sent to the eligible candidates. List of the eligible candidates to be called for viva voce test will be uploaded in the Official website of Goalpara District Judiciary and candidates will download the same from the Official website. The list of rejected candidates will also be uploaded in the Official website.

12. All information regarding the list of eligible/rejected candidates, date of viva-voce test etc. will be intimated in the Official website and Notice Board of the Office of The Chief Judicial Magistrate, Goalpara only. Candidates are advised to check the official website and notice board of the Office of The Chief Judicial Magistrate, Goalpara regularly.

13. No TA/DA will be admissible to the candidates for appearing in the viva-voce test etc.

14. Place and date of the viva-voce test will be uploaded in the official website of Goalpara District Judiciary.


15. Application received late or without proper supporting documents or unsigned or incomplete/defective will be summarily rejected, without any further intimation.

If any candidate is found to have suppressed his/her educational qualifications or given any wrong information at the time of applying for the job or later on, his/her candidature shall stand rejected without any information to him/her with immediate effect and shall also be liable to Criminal Prosecution as per law.
