Applications are invited from the Indian Citizen (local residents of Goalpara District) for selection of Para Legal Volunteers (PLVs) in the prescribed format enclosed with the advertisement along with two numbers of passport size Photograph, for selection of 20 (twenty) numbers Para Legal Volunteers (PLVs) under District Legal Services Authority, Goalpara.

1. Eligibility:

- PLVs shall be literate, preferably matriculate with a capacity for overall comprehension.
- Retired Teachers
- Retired Government servants and senior citizens.
- Anganwadi Workers
- Students & Law Students
- Members of non Political, services oriented NGOs and Clubs
- Doctors/Physicians
- Members of Women Neighbourhood Groups, Maithri Sanghams and other Self Help Groups including of marginalized/Vulnerable groups
- Educated prisoners with good behavior, serving long term Sentences in prisons
- Any other persons whom the District Legal Services Authority or Taluk Legal Services Committee deems fit to be identified as PLVs.

2. The last date for submission of applications will be on 20.02.2024 during office hours.

3. The applications should be should be addressed to “ **The Chairman, District Legal Services Authority, Goalpara, District JudiciaryComplex, Bhalukdubi, PO, PS, & Dist. Goalpara, Pin-783101, Assam**”.

4. The applications should be dropped in the DROP BOX kept in the premises of the office of the District Legal Services Authority, Goalpara, District Judiciary Complex, Bhalukdubi, Goalpara, Assam on or before last date.

5. Applications submitted in any other mode such as by post, email, etc. except as indicated above, will be summarily rejected without any communication.

6. Eligible applicants will be selected through the mode of Personal Interview (Date to be notified).

7. The List of eligible candidate for personal interview will be published in the website of District Judiciary, Goalpara and the notice board of the undersigned.

8. No separate Call letters will be issued to the candidate for personal interview.

9. No TA/DA shall be paid to the applicants for attending personal interview.

10. Incomplete application shall be rejected without assigning any reasons.

11. Selected Para Legal Volunteers shall be required to undergo training programme as per decision of the District Legal Services Authority, Goalpara.

12. The decisions of the selection Committee in short listing the number of candidate for interview and selection of PLVs shall be final. The eligible candidates shall have to appear for interview before the selection committee on the date which will be notified in the official website.

**Remuneration:** The works of PLVs do not carry any salary, remuneration or wages except honorarium fixed by DLSA, Time to time.

**Job Profile:** PLVs should not look up to the income they derive from their services as PLVs, but they should have a mind set to assist the needy in the society coupled with compassion, empathy and concern for upliftment of marginalized and weaker section of the society. They must have unflinching commitment towards the cause which should be translated into the work they undertake.
