

Resolutions of the District Committee for Infrastructure and Building of District Judiciary, Goalpara held on 07-09-2024 at 4.00 PM in the Official Chamber of District and Sessions Judge, Goalpara

Today, a meeting of the District Committee for Infrastructure and Building of District Judiciary, Goalpara is held in the official chamber of the District and Sessions Judge, Goalpara consisting of the Chairman –cum- District and Sessions Judge, Goalpara, Member -cum- Addl. District and Sessions judge, Goalpara, Member -cum- Chief Judicial Magistrate, Goalpara, special invitee SDE, APDCL, Goalpara, JE PWD Building Division, Goalpara, SO, PWD Electrical division, Goalpara and Supervisory Asstt. Balijana circle, Goalpara and the said Committee have unanimously adopted the following resolutions:

1. The Executive Engineer, PWD, Electrical division, Kokrajhar is directed to submit the status report of all the countersigned estimate i.e. 30 KVA DG set for Addl. Court Building, CCTV of existing and addl. Court building, AMC for AC machine 2023-24, Installation of AC, Gyser, chimney, water purifier at grade -1 quarter, installation of AC, exhost fan, water purifier at addl. Court building, Lift for grade -1 quarter, Solar servicing, installation of AC at LADC office, Rewiring of electrical installation at quarters etc.
2. The committee asked the Executive Engineer, PWD, Electrical division Kokrajhar and the Sub Divisional Engineer, APDCL, Goalpara to jointly check the transformer of existing court building, whether the electrical power among the three phases is distributed properly or not and if not then make necessary arrangement for doing the needful at the earliest.
3. The Executive Engineer, PWD, Electrical division, Kokrajhar is also asked expedite the sanction procedure of the plan and estimate of CCTV surveillance system in the existing Court building and installation of AC, Gyser, Chimny, Water purifier etc. at Grade-1 quarter.
4. The Executive Engineer, PWD, Electrical division, Kokrajhar is directed to do necessary arrangement for rewiring of quarter no 3 and quarter no 1 on priority basis. He is also requested to submit plan and estimate for illumination of Court building by LED fittings, Residential campus lighting by LED lights with Solar power plant and high mast light at addl. court building campus.
5. The Executive Engineer, PWD, Electrical division, Kokrajhar and SDE, APDCL, Goalpara is directed to expedite the process of shifting of over head H. T electricity line of APDCL from the campus of Addl. Court Building.
6. The Circle Officer, Balijana Block is requested to resolve the demarcation problem of grade –I quarter campus immediately.

7. The Executive Engineer, PWD, Building division, Goalpara is requested to expedite the sanction procedure of addl. estimate of Addl. Court building and grade-1 quarter. He is further requested to complete the work of grade -I quarter and hand over the building at the earliest.
8. The Executive Engineer, PWD, Building division, Goalpara is directed to make necessary arrangement for cleaning of water tanks installed at Court complex and Quarters. He is also requested to check properly the tin shed of conference hall and change the stained ceiling board of conference hall.
9. The Executive Engineer, PWD, Building division Goalpara is asked to make necessary arrangement for temporary record room beside Addl. CJM's Court Room and fencing for gardening in the front side of the Court Complex.
10. The Executive Engineer, PWD, Building division, Goalpara is directed to submit plan and estimate for retaining wall, drainage system and approach road of staff quarter.


