Admit Cards of accepted candidates shall be uploaded in the Official Website of District Judiciary, Goalpara (<https://goalpara.dcourts.gov.in/>) on 24.04.2025. As such, concerned candidates are hereby requested to **download the Admit Card** from the official website. **No separate call letters will be issued to the candidates.** If any candidate cannot download his/her Admit Card from the website, he/she may also collect the same from the office of the District Legal Services Authority, Goalpara from 28.04.2025 to 30.04.2025 during office hours.

Grievances regarding non inclusion of name in the provisional list may be brought to the notice of undersigned with copies of supporting documents, within 7 days from the date of publication of this notification. No objection will be entertained after 7 days of the publication of the notification.

Candidates of the provisional list have been allowed to appear in the Written Examination subject to the condition that their candidature will continue to be under scrutiny. The Selection Board reserves the right to reject the candidature of any candidate on detection of any ineligibility condition at any stage.

## **Syllabus for the Written Examination**

The Written Examination shall be held of 100 marks of 2 hours (120 minutes) duration comprising of following subjects:

- i. General English,
- ii. General knowledge/Current Affairs,
- iii. Mathematical Ability,
- iv. Reasoning,
- v. Drafting,
- vi. Computer knowledge,
- vii. Knowledge of Assamese language.

### **Terms and Conditions for the Candidates appearing in the written examination:**

1. The candidates must have to bring Admit card along with one photo identity card in original (Aadhar Card, Driving license, Voter Id) issued by the Government Authority without fail. Without the admit card and original photo identity card the candidates will not be allowed to enter in the examination hall.
2. Candidates have to report at the venue of the examination hall half an hour prior to the commencement of the examination.
3. No candidate will be allowed to enter the examination hall/room after 30 minutes of the commencement of the examination.
4. One answer sheet will be given to each of the candidates where they will write their answers, write roll no., put their signatures and hand over the same after the examination. Only one answer sheet will be provided to the candidates for the purpose of the examination as such candidates have to carefully fill up the Roll Nos. only.
5. Candidates are to bring their own pen (blue/black) for the purpose of writing the answers on Answer Sheet.
6. No candidate will be permitted to leave the examination hall during the two hours of the examination.

- 7. Carrying of bags, books, mobile phones, calculators, smart watch and any other electronic gadgets inside the examination venue are strictly prohibited.**
8. Candidates found in possession of mobile phones or such electronic gadgets as mentioned during the time of examination will be disqualified.
9. The authority shall not be liable for loss of any items of the candidate.
10. Violation of any of the above instructions and adoption of any unfair means in the examination will entail cancellation of the candidature of such candidate.
11. The issuance of Admit Card is purely provisional and it does not mean acceptance of candidature of any candidate. The candidature of any candidate is under scrutiny and the Authority reserves the right to reject the candidature at any time.
12. Discrepancy, if any, noticed in the Admit card should be brought to the notice of the Authority, in writing within 7 days from the publication of the Admit Card.
13. Canvassing directly or indirectly or in any form will disqualify the candidature of the candidate.
14. No TA and DA will be provided for appearing in the said examination.
15. No separate call letters shall be issued to the candidates for written examination.
