Bids received after the due date/time shall not be entertained. The received bids shall be opened in this Office on 23rd day of April ,2025@ 2pm.

The general terms and conditions to be annexed with the tender notice will be as hereunder:

- (i) The vehicle provided for hire should be of latest model and in the good running condition. Preference will be given to new vehicle & which isn't more than 1(One) year old. The vehicle should be in neat, clean and in perfect condition with a clean interior and proper in upholstery.
- (ii) The vehicle should be comprehensively insured and should carry necessary permits, clearance from the Transport authority or any other concerned authority. The vehicle should also carry necessary pollution certificate issued by the competent authority, Undertaking in this regard is required to be submitted by the tendered along with his/her tender.
- (iii) The vehicle shall be at the disposal of the hiring establishment during the contract period and the said vehicle cannot be withdrawn during the existence of the contract without the express consent of the hiring authority.
- (iv) In case of any mischief , theft or accident the hiring establishment shall not be liable and stand indemnified.
- (v) All source of maintenance and repairing of the vehicle shall be done by the outsourcing vendor which excludes the driver and fuel.Non

- incumbency Certificate shall be done by the outsourcing vendor .
- (vi) The rates quoted shall be valid for 1(one) year from the date of awarding the work of hiring vehicles by the office of the District & Sessions Judge, Goalpara or till new vehicle is provided by the Government/ High Court to the Addl. District & Sessions Judge, Goalpara whichever is earlier.
- (vii) The outsourced vehicle should be free from any encumbrances.
- (viii) In the event of any unsatisfactory performance of the vehicle or non-compliance with terms and condition of the contract shall be terminated without assigning any reason whatsoever in case of such termination ,services of other empanelled service provider will be utilized at the contracted rate.
- (ix) The interested parties must be SBI account holder and the GST, Registration Card etc. shall be furnished by the vendor for online payment of bill.
- (x) The tender /quotation shall be submitted in a sealed envelope marked as "Tenders for outsourcing vehicle".
- (xi) The payments to the vendor/service provided shall be made through online after submission of bill.
- (xii) Incomplete quotation of bids not accompanied with the requiste supporting documents or

quotation without sealed envelope shall be summarily rejected without assigning any reason and without any communication.

- (xiii) Road worthiness of the vehicle shall be ensured at all times by the vehicle provider. The maintenance of vehicle shall be done by the outsourcing vendor. The outsourcing vendor/service provider will conduct regular cleaning and washing as well as serving (as and when due) of the vehicles.
- (xiv) The bill for the payment of the hiring charges shall be submitted to this office by the contracted agency at the beginning of the following months. No payment in advance shall be made to the contracted agency/vehicle provider by this office.
- (xv) The service provider shall undertake to indemnity the office of the District & Sessions Judge, Goalpara against all the damages/ charges arising out of or connected with the negligence of service provider. Whether concerning public or any person in gereral while executing the contracted work or other wise and against all the claims and demand thereof.
- (xvi) The vehicles may be physically inspected on the date of opening of the bids by the committee. The service provider on being intimated over telephone / mobile must be ready to place the concerned vehicle in the office premises of the

District & Sessions Judge, Goalpara for such physical inspection.

- (xvii) This committee reserves the right to reject any bid without assigning any reasons if there appears to be reasonable and probable cause for same.
- (xviii) The undersigned also reserves the right to secure the fulfillment of other condition not expressly mentioned herein which are otherwise consistent with and necessary as per law with the use of hired vehicles.
