No.MACT/GLP/2026/17 # As per the Selection Board Meeting Resolution Dated 08/01/2026, applications are hereby invited in the Standard Form Part IX of Assam Gazette along with caste and educational certificates from the intending candidates for filling up 01 (one) vacant post of Peon, now called Multi-Tasking Staff (Group D-II employee as per the Draft Assam District Court Employees Service Rule, 2018) in the office of the Motor Accident Claims Tribunal, Goalpara in the Pay Band and Grade Pay with other allowances as admissible under Rules as shown below.

**Terms and Conditions**

1. Candidates must be an Indian Citizen.

2. Candidates already serving in Govt. Department should submit their application through proper channel.
3. **Candidates must have passed Class VIII but Candidates who have passed H.S. or above shall be ineligible to apply for the aforesaid post.**
4. If any candidate is found to have suppressed his/her educational qualifications or given wrong information at the time of applying for job or later on, his/her candidature shall stand rejected with immediate effect and the candidate may be liable to Criminal Prosecution.
5. Candidates must not be less than 18 years of age or more than 40 years of age as on 01/01/2026. The upper age is relaxable as per Govt. norms for OBC/SC/ST candidates.
6. The application with self-attested copies of all testimonials regarding Educational Qualification, Age, Caste along with 03 (three) copies of recent passport size photographs duly signed by the candidate on the reverse side should reach the office of the undersigned on or before the last date fixed. Furthermore, candidates shall give a self-declaration that they have not qualified H.S 2nd year (Class-XII) examination. They shall also submit copy of Voter card or Employment Exchange Registration card showing permanent residency in the state of Assam.
7. **The applicant should mention their mobile number in the application without fail.**

8. **The last date of receipt of application form is 16/02/2026 up to 4:00 P.M.** No application will be accepted after the last date of submission.
9. Envelope containing application should indicate the name of the post and category to which they applied for on the top in the Block letters as "**APPLICATION FOR THE POST OF MTS (Group D-II)**". Those who failed to do so, their application may not be considered.
10. The Selection Board has decided to hold a two stage recruitment process. Initially (i) a written test (MCQ) of 50 marks and (ii) the short listed candidates shall be called for viva-voce of 20 marks.
11. The list of eligible candidates and list of rejected candidates shall be notified on the District Judiciary website (<https://goalpara.dcourts.gov.in/>).
12. The date and place of written examination shall be thereafter duly notified on the District Judiciary website. All eligible candidates appearing for the written examination shall appear with a credible photo identity card. No separate call letters will be issued. Applicants are advised to go through the official website regularly.
13. After scrutiny of written examination paper, the short listed candidates shall be notified to appear for the viva-voce on the District Judiciary website.
14. Preference will be given to those candidates who are having professional skills like driving/plumbing/electrical skills subject to their qualifying the written examination.

15. The applicants shall submit their application in a drop box made available for the same in front of the office of the Member, MACT, Goalpara, located in District Court Complex, Goalpara. They may, in the alternative, submit their application through ordinary postal service, registered post or speed post. Application sent through private courier service will not be entertained.
16. Application received late or without proper supporting documents or unsigned or without photographs or incomplete Application Form will be summarily rejected. Decision of the Selection Board on these aspects shall be final.
17. No TA/DA will be admissible to the candidates for appearing in the written test or viva-voce.
18. Canvassing directly or indirectly shall disqualify a candidate.
19. **No electronic device, mobile phone, smart watch or other Bluetooth device be carried by any candidate to the examination centre. Any candidate found with such device may face criminal prosecution.**
