Note:-


[1] All the successive bail application filed under the same offence and by same accused or co-accused be placed before the same judge who had decided the previous bail application, even if the trial of case pending at any other concerned Courts.

[2] All the Applications arising out of the same offence Crime Register number may be decided by the same Judge, until the Presiding Officer is not transferred and the same should be placed before same Officer.

[3] All the Execution Petitions and Miscellaneous Application filed under the Motor Vehicles Act, be placed before the Tribunal on whose file the particular Motor Accident Claim Petition, is pending OR be placed before the Tribunal, who has decided the particular Motor Accident Claim Petition.

[4] All the time of institution of Miscellaneous Application filled in Motor Accident Claim Petitions for disbursement of awarded amount, the order regarding "Nazir to verify and Report" be passed and be placed before the Tribunal who has passed order/ decree.

[5] Bail Application under the POCSO Act, the scheduled castes and Scheduled Tribes (Prevention Atrocities) Act 1989, the Prevention of Corruption Act 1988, the N.D.P.S. Act and under any Special Acts should be placed before the Special Court for necessary Order.
