CANDIDATES WILL BE SELECTED STRICTLY ON THE BASIS OF MERIT.

For L.D.C

Candidates will have to undergo Type Test on computer having at least speed of 30 word per minute (50 Marks), qualifying candidates at a ratio (1:6) will be eligible to sit in the written examination consisting of Total 85 Marks (English -30, G. K & Current Affairs- 30 & Mathematics -25), qualifying candidates at a ratio of (1:3) will be eligible for Viva -voce consisting of 15 marks.

For Driver

Candidates will have to undergo Motor Driving Test of 80 Marks, qualifying candidates at a ratio (1:6) will be eligible for Oral Interview consisting of 20 Marks. (The candidate must be medically fit for driving).
