The Hon'ble High Court is pleased to order all the Judicial Officers of Tripura to utilize the DSC Class-III Token for digitally signing the judgments, orders, letters, notifications, circulars etc. w.e.f. 1<sup>st</sup> January, 2022 and upload the digitally signed documents in the Case Information System (CIS) Software and the websites of the District Courts. The Judicial Officers shall submit the attached "Receipt -cum-Acknowledgment" in PDF format digitally signed through the DSC Token after receiving the same and send it to the Dy. Registrar (Judl.)-cum-CPC via email (cpc-trp@aij.gov.in) with subject line as "DSC Token-Name of the Judicial Officer, Designation".

The default password of the DSC Token shall be sent by the Registry to all the Judicial Officers via SMS and email in their registered mobile number and Email ID. The Judicial Officers are directed to Page 1 of 3 secure the password by changing it after first use and keep the DSC Token safely with them.

The enlisted Judicial Officers are directed to collect their respective DSC Class-III Token from the System Analyst, Computer Section of this Registry either in person or through a responsible messenger with authorization.

#### <u>Receipt-cum-acknowledgement for DSC token to be signed</u> by the Judicial Officers

I acknowledge that I have received Digital Signature Certificate token allotted to me by the Hon'ble High Court. I have also read and understood the guidelines for using the Digital Signature Certificate token issued by the High Court of Tripura as shown below:

**1.** The Judicial Officer, when retires from service, he/she should hand over the DSC token to the High court.

**2.** The Judicial Officer under suspension should not use Digital Signature during the period of suspension.

**3.** The Judicial Officer may use the DSC to sign all the Digital Documents including judgments, orders, letters, notifications, & circular etc.

**4.** In the event of Digital Signature Certificate token misplaced by the Judicial Officer, a FIR/GD entry may be lodged under the intimation to the High Court.

**5.** The Judicial officers are advised to go through the Information Technology Act, 2000 and the Rules framed there-under for more information about the Digital Signature.
