MEMORANDUM

In pursuance of the order vide No. F. 44(1)(c)-HC/2022/16581, dated 10.07.2022 issued by the Hon'ble High Court of Tripura, Agartala and in view of sudden surge in COVID-19 positive cases in the State of Tripura and for the purpose of containing the spread of Corona Virus within the State, it is hereby ordered that every one present in the premises of District & Sessions Judge, Gomati Judicial District, Udaipur and Sub-Divisional Judicial Magistrate-Cum-Civil Judge (Jr. Div.), Amarpur, Gomati Judicial District to maintain social distancing norms strictly and mandatorily. All health advisories issued by the Central/State Government from time to time must be followed in letter and spirit at all times. In addition, adherence to all safety measures, wearing of face mask in proper manner, cleaning of hands at regular interval using soap/sanitizer etc. are compulsory for every person, be it a lawyer or a litigant or staff members. No person with symptom of fever shall be allowed to enter into the aforesaid court premises under any circumstances.

For implementation of safety measures and health advisory issued by the Central/ State Government as well as Hon'ble High Court, Head Clerk (Nazir) of this establishment/Nazir of the Court of Sub-Divisional Judicial Magistrate shall ensure proper arrangement for providing of hand wash/sanitizer to the lawyers, litigants and the officials of this judgeship at all entry points. To ensure strict maintenance of social distancing, wearing of face mask in proper manner etc. within the court premises, *a team comprising of Head of Office, Senior Sheristadar & Nazir will keep vigil.*

Moreover, any official of this Judgeship having Covid-like symptoms must go through the COVID Test (Antigen/RTPCR).
