Subject: - Arrangement of Duty Roster of Judicial Officers during long vacation (Puja vacation) 2023, commencing from 20-10-2023 to 15-11-2023.

The annual long vacation (Puja Vacation) during the year 2023, will commence w.e.f 20-10-2023 and will continue upto 15-11-2023 in pursuance of the Notification vide No.F.42(1)-HC/2022/30607, dated 08-12-2022 and as per approval vide No.F.41(139)-HC/2023/26166-81, dated 17-10-2023 of the Hon'ble High Court of Tripura, Agartala.
