
The candidates eligible for Viva voce required to produce following certificates/documents during the time of Viva voce for verification without fail.

- 1) SSLC examination passing marks card.
- 2) II PUC /Diploma /Equivalent Marks card.

- 3) English Typewriting Senior Grade Marks Card/ Equivalent Marks card.
- 4) Kannada Typewriting Senior Grade Marks Card/ Equivalent Marks card.
- 5) Caste & Income Certificate
- 6) Rural Student Certificate (from 1st Std to 10th Std) for those who have claimed reservation.
- 7) Candidates who are claiming reservation under General Merit (Rural Category) have to submit their non-creamy layer certificate apart from Rural Student Certificate.
- 8) Candidates who are claiming reservation under Disabled Persons shall furnish Disability Certificate issued by the competent authority in the prescribed manner.
- 9) The candidates who are claimed age relaxation, shall furnish the necessary certificate.
- 10) ID proof of Aadhar/Voter ID
- 11) Three Character certificates (one from institution last studied and two from respective persons).
- 12) Any other documents, if necessary.

If the candidates fail to produce original documents at the time of Viva voce, their candidature will not be considered for selection.

The separate intimation regarding Viva voce will not be sent through post. The e-mail and SMS will be sent to the concerned candidates and also will be notified in the official website (<https://kodagu.dcourts.gov.in/notice-category/recruitments/>) of the District Court, Kodagu-Madikeri.
