- 4) The decision of the Selection Board regarding the acceptance and rejection of the candidature of any candidates/advocates shall be final and binding.
- 5) If the date of interview/viva-voce gets cancelled due to any unforeseen circumstances, the next date of interview/viva-voce will also be notified Golaghat District Judiciary website.

 - (i) Proof pertaining to date of birth, copy of Aadhaar and PAN Card. (Self-attested)
 - (ii) Copy of Graduation Degree. (Self-attested)
 - (iii) Copy of Law Degree. (Self-attested)
 - (iv) Copy of Certificate of enrolment issued by the Bar Council concerned. (Self-attested)
 - (v) Experience Certificate from the concerned District Judge or Presiding Officer of the Court or Tribunal where the applicant practices as an Advocate.
