### 2. ELIGIBILITY CRITERIA:

- i. Minimum educational qualification for the post is HSLC passed.
- ii. The candidate must possess a valid driving license (LMV).
- iii. The candidate should have the knowledge of Official Language of the State of Assam (Assamese).
- iv. The candidate must possess Employment Exchange Registration number for the State of Assam.

### 3. AGE LIMIT:

The candidate should not be less than 18 years and not more than 40 years of age as on 01.01.2024. Age relaxation shall be as per Govt. norms for reserved categories.

#### 4. SELECTION PROCESS:

#### 5. HOW TO APPLY:

i. The candidate shall have to submit self attested documents (photocopy) of all educational qualification, age proof, caste certificate, valid driving license and other necessary testimonials along with 3 copies of recent passport size photographs along with the application form.

- ii. The candidate must indicate prominently the name of the post applied for on the right hand corner of the envelope containing the application.
- iii. The candidate must provide their contact (mobile) no. in the application form.
- iv. Candidates serving in Govt. department must apply through proper channel.
- v. Completed applications along with all testimonials as mentioned above should be addressed to "The District & Sessions Judge, Golaghat-P.O. Golaghat, PIN-785621, Assam".
- vi. Applications sent through post super scribed as "Application for the Post of Driver (Fixed Pay)" should reach the office of the undersigned on or before 20.01.2024 (within office hour).
- vii. Candidates may also drop their applications in the "Drop Box for the post of Driver (Fixed Pay)" to be kept at the premise of Office of the District & Sessions Judge, Golaghat on or before 20.01.2024 (within office hour).

#### 6. TERMS AND CONDITIONS:

If, it is found that a candidate does not fulfil any of the eligibility conditions, his/her candidature shall stand cancelled without any prior notice.
