A reject list (s) with ground of rejection has also been uploaded.

Note:-

1. No individual call letters will be issued to the eligible candidates.
2. Calling of the candidates for the said driving test is purely provisional and does not mean acceptance of their candidature, which shall be further scrutinized by the Selection Committee, which reserves the right to reject the candidature of any candidate at any time.
3. The decision of the Selection Committee regarding the acceptance and rejection of the candidature of any candidate shall be final and binding.
4. If the date of driving test gets cancelled due to any unforeseen circumstances, the next date will also be notified via Golaghat District Judiciary website.
5. The candidates will not be entitled for any T.A./ D.A. or any other expenses for appearing in the said driving test.
