Applications are invited on or before 20/06/2024 from the eligible candidates under this Judgeship for filling up 1 (one) post of Upper Division Assistant (UDA) in the pay scale Rs. 14,000-Rs. 70,000 + Grade Pay Rs.8,000/- which is lying vacant in the office of the District Legal Services Authority, Golaghat.

Eligibility Criteria:

- (1) Candidate must have rendered continuous service as Lower Division Assistant (LDA) for at least 5 (five) years as on 01.01.2024
- (2) He/she must be a permanent resident of the State of Assam.

Selection Process:

Oral Interview/ Viva –Voce of 50 marks.

How to apply :

- (1) The applicants must submit their application in a Standard Form of Application published in the Assam Gazette Part-IX with self attested photo copies of all testimonials Through Proper Channel only.
- (2) The testimonials must necessarily contain NOC from his/her current employer, copies of ACR for 3 (three) years, Service Book and other relevant documents.

- (1) The date of interview/Viva-Voce will be on 25th June, 2024. The list of eligible candidates along with the time and venue of interview shall be uploaded in the official website of District Judiciary, Golaghat (<https://golaghat.dcourts.gov.in>). No separate call letters will be issued. Applicants are requested to refer to the official website.

- (2) Canvassing directly or indirectly shall be liable for disqualification of the candidate.
- (3) The District & Sessions Judge-cum-Chairman, DLSA, Golaghat reserves the right to alter/modify or change any terms or conditions including selection criteria etc. mentioned in the advertisement.
- (4) The admission of candidates at all stages of selection process will be purely provisional and subject to satisfying the prescribed eligibility conditions by way of furnishing documentary evidence in support thereof. In on verification at any time before or after the selection process, it is found that a candidate does not fulfill any of the eligibility conditions, his/her candidature shall stand cancelled. Mere calling of candidate to the interview/ viva-voce does not necessarily mean acceptance of candidature.
