


Applications were invited for Contractual Engagement of 1 (one) no. of Office Assistant, 1 (one) no. of Receptionist-cum-Data Entry Operator and 1 (one) No. of Peon in the office of the Legal Aid Defense Counsel System, Golaghat, as per the LADCS Modified Scheme, 2022 of NALSA, vide Advertisement No. DLSA/GLT/2024/1190-1193Dated Golaghat the 13th June, 2024, published in the official website of the District Judiciary, Golaghat and in the news papers namely "Dainik Janambhumi" and "The Assam Tribune". A total 287 applications were received and out of them 118 applicants for Office Assistant, 64 applicants for Receptionist-cum-Data Entry Operator and 99 applicants for the post of Peon are found eligible for appearing in the interview and 6 Nos. of applications are rejected. - 4. No TA/DA will be admissible to the candidates for attending the interview.
- 5. The decision of the Selection Board in all matters would be final and binding on the candidates.
- 6. Canvassing in any form for selection including change of date, time, venue etc. shall be treated as disqualification.
