

6. Panel for Retainer Lawyers.


The Applications **shall be accompanied with proof of the professional experience** with special reference to the type of cases, which the Applicant legal practitioner may prefer to be entrusted with.

The Applicant may submit the Application by writing in his/her own hand but in legible handwriting or in computer typing form. A passport size photograph, a copy of the Licence issued by the Bar Council showing the period of practice need to be appended with the Application.

Choosing of a particular Panel by the Applicant does not give him/her the right of selection in that particular panel.

The Panel Lawyers who shall be designated as Retainers shall devote their time exclusively for legal aid works and shall be always available to deal with legal aid cases and to man the front office in respective legal service institution.

The last date for receipt of the Application shall be 15(fifteen) days (during office hours) from the date of publication of the Notice.
