With reference to the above referred letter on the subject captioned above, I am directed to inform you that the Hon'ble High Court has been pleased to accord its kind Administrative Approval to the plan & estimate and expenditure sanction for an amount of Rs.1,99,997/- for civil works of the construction of the eSewa Kendra at Dharmanagar Court Complex.

It is pertinent to mention here that as per your letter no.F.16(16)-DJ/N/DMN/2020/6576-77 dated 24/09/2020, you have informed the High Court that the SDO, PWD (R & B), Dharmanagar Division has agreed to provide electricity connection to the eSewa Kendra with the permissible expenditure limit as per the Project Implementation Guidelines. Hence, no funds have been separately released for electrical works of the eSewa Kendra of Dharmanagar Court Complex.


