

A. Scope of work

The main objective of this project is to appoint third-party vendor for repair of 8 port 10/100 Base Tx Fast Ethernet Switch with combo interface for LAN connectivity by Hon'ble High Court of Tripura which is installed in the Court Complex of District & Sessions Judge, North Tripura, Dharmanagar.

B. Terms & Conditions

1. Vendor(s) are requested to Survey the sites physically and to submit the quotations.
2. Amount quoted in the quotation shall be inclusive of all taxes.
3. The quotationer should submit proper documents by mentioning yearly turnover of the company and the yearly turnover should be minimum 2 (Two) Lakhs.
4. The components /parts used by the vendor should be authentic and original. In case of hardware breakdown and if in case any part /equipment is beyond repairs and the same is not available/technology is obsolete or end of life, the same will be replaced with an equivalent or higher of replacing hardware.
5. Min 6 (Six) months warranty is mandatory if any spare is replaced from the date of repair.
6. Taxes (at source) will be deducted as per applicable rules.
7. Quotation shall be submitted by 4:30 pm on or before 31st August, 2021. Any Bid received after the deadline for submission of Bids prescribed, shall be rejected and returned in unopened condition to the Bidder.
8. The Said Tender/Quotation shall be opened in the chamber of Ld. District & Sessions Judge on 31st August, 2021 at 5:00 pm in presence of the Quotationers who may desire to be present.
9. The date of Opening of the quotation may, however, be changed if required at the discretion of the Authority with intimation to the Quotationer.
10. Required following document should be accompanied with the tender that is PAN card, Trade License, CST, IGST, GST Registration & clearance, yearly turn-over certificate, under taking regarding acceptance of terms and conditions.
