
Fees:- ₹ 200/- for UR Category and ₹ 100/- for ST/SC category.

Candidates will have to sit in the Written Examination consisting of total 75 Marks(Letter Writing in Bengali-25, Hand Writing Test(English & Bengali-25), G.K. & Current Affairs-25) to qualify for Viva Voice Test (25 marks).

Candidates will be selected strictly on the basis of Merit.

How to apply

1. Application in plain paper as per prescribed format addressed to the District & Sessions Judge, North Tripura, Dharmanagar along with self-attested copies of relevant certificates & testimonials 3(three) recent self attested passport size photographs along with fees for conducting examination/test for the recruitment in the nature of **Crossed Bank Draft**, from any nationalized Bank, payable at Dharmanagar in favour of the **District & Sessions Judge, North Tripura, Dharmanagar** should reach the Office of the undersigned on or before **01-06-2018** along with **Crossed Bank Draft of ₹ 200/- for UR Category and ₹ 100/- in case of ST/SC category** .
2. Application may be submitted by hand in the Office of the undersigned on all working days between **11 am to 5 pm**.
3. **Age Limit:- Minimum 18 years and maximum 40 years for UR and releasable by 5 years in case of ST/SC/PH candidates and Govt. Servant(as on 01-01-2018)**
4. **Reservation for candidates belonging to reserved categories will be as per rule.**
5. The department shall not be responsible for delayed postal delivery of application beyond the date fixed.
6. Incomplete applications will be summarily rejected.
7. Candidates already in service must apply through proper channel or attach **"No Objection Certificate"** from his employer along with the application.
8. Any application by post or hand received after **01-06-2018** shall not be entertained.
9. **The venue, date & time of written test/viva voice test etc. shall be informed in due course of time.**
10. No **TA/DA** shall be paid for attending any test for the selection process.
