Applications are invited in the prescribed format attached herewith [also available in notification link in the official Website of the District & Sessions Judge, North Tripura, Dharmanagar (<https://northtripura.dcourts.gov.in/notice-category/recruitments/>)] from the local residents of the North Tripura District for engagement of 04 (Four) no's of Para Legal Volunteers in the roll of District Legal Services Authority, North Tripura, Dharmanagar.

Who May Apply?	Teachers (including retired teachers) Retired Government servants and senior citizens. M.S.W students and teachers. Anganwadi Workers. Doctors/Physicians. Students & Law Students (till they enroll as lawyers). Members of non-political, service oriented NGOs and Clubs. Members of Women Neighbourhood Groups, Maithri Sanghams and other Self Help Groups including of marginalized/vulnerable groups. Any other person whom the District Legal Services Authority deems fit to be identified as PLVs.
Eligibility Criteria:	I. Applicant must be a Permanent Resident of North Tripura district and; II. Minimum educational qualification of the applicant must be Madhyamik Pass from any recognized Board and; III. Applicant must have basic knowledge in Computer.

Applicants will be selected through walk-in-interview on the basis of Merit.

N.B: The work of PLVs does not carry any salary, remuneration or wages except honorarium fixed by the DLSA from time to time.

Honorarium: Rs. 500/- per day is the fixed honorarium, at present paid to the PLVs on the basis of no work no pay as per the Guidelines framed by Tripura State Legal Services Authority, Agartala to ceiling limit of 20 days of working in a month. However, such term/condition is subject to such change/modification/ alteration as may be ordered by the competent authority.
