## 1) Eligibility for the post of Personal Assistant/ Steno Typist:

- a) Must have retired from service in the Cadre of Stenographer Grade-III and above cadre in A.P. Judicial Ministerial & Subordinate Services and not completed 65 years of age and the candidates having at least one year of age to complete 65 years of age by the date of appointment.
- b) Who have passed A.P. Government Technical Examination in English Short hand by Higher Grade, provided that, if the candidates who have passed the examination by the Higher Grade are not available, those who have passed the examination by the flower grade will be considered.

### 2) Eligibility for the post of Junior Assistant – Cum – Typist :

- a) Must have retired from service in the Cadre of Junior Assistant ( Category-8) / Typist (Category-9)/ Field Assistant Category-10) and above cadre in A.P. Judicial Ministerial Subordinate Services and not completed 65 years of age and the candidates having at least one year of age to complete 65 years of age by the date of appointment.
  - b) Who have passed A.P. Government Technical Examination in English Short hand by Higher Grade, provided that, if the candidates who have passed the examination by the Higher Grade are not available, those who have passed the examination by the lower grade will be considered.

#### **General Instructions.**

- 01. The persons who have retired on any punishment for any misconduct in disciplinary proceedings while in service are not eligible for consideration.
  - 02. The persons shall be of sound health and active habits.
- 03. The persons with proven ability, good performance and integrity alone will be considered.
- 04. The term of re-employment will be determined from time to time by the Hon'ble High Court.
- 05. The persons who have taken voluntary retirement on the ground of medical invalidation, retired on compulsory retirement from service, dismissed, or removed from service, shall not be eligible for the appointment for the Post of Personal Assistant/ Steno typist, and Junior Assistant cum Typist. ....3

- 06. The appointment for the Post of Personal Assistant/ Steno typist, and Junior Assistant cum Typist shall be for a period of one year from the date of assumption of the charge and if the work of the persons holding the said Post is satisfactory, such persons will be considered for re-appointment for the subsequent period.
- 07. The Principal District Judge, Chittoor is competent to terminate the service of any person appointed to the Posts of Personal Assistant/ Steno typist, and Junior Assistant cum Typist at any time, if the work is not satisfactorily or there is any physical disability or on the grounds of misconduct or negligence subject however to giving an opportunity of making representation in the last mentioned event viz., "Misconduct or negligence "
- 08. Preference will be given to those candidates who have experience in the respective field.
- 09. The Persons who may be appointed for the posts of Personal Assistant/ Steno typist, and Junior Assistant cum Typist has to produce Medical Fitness Certificates showing that he/she is physically and mentally fit to hold the post and enter into an agreement/contract with the District Court, Chittoor on such terms and conditions.
- 10. The appointments will be made <u>on contract basis</u> as per Rule 9 of A.P. State and Subordinate Services Rules, 1996 and they have to enter into contract/agreement in the prescribed proforma.

The applications/willingness letters received after due date will not be considered under any circumstances.
