

PROCEEDINGS OF MEETING OF SELECTION COMMITTEE FOR COMPLETION OF PROCESS OF SELECTION OF COUNSELLORS (One CHILD COUNSELLOR & Two GENERAL COUNSELLORS)

Today on 07.03.2024 a meeting of Selection Committee was held under the Chairmanship of District & Sessions Judge-cum-Chairman, District Legal Services Authority, Pathankot to draw the time limits for completion of process of selection of counsellors (One Child Counsellor & two General Counsellors) .

Secretary, District Legal Services Authority, Pathankot has put up before the Committee the letter No. 549 dated 25.01.2024 of Punjab State Legal Services Authority, S.A.S. Nagar whereby directions have been issued to complete the entire process of engagement of (One Child Counsellor & two General Counsellors) by 20.03.2024.

Secretary, District Legal Services Authority, Pathankot has further stated that total 09 applications have been received for the post of Child Counsellor and 20 applications have been received for the post of General Counsellors, out of which 06 applicant namely Ms. Anshu Shukla D/o Sh. Raj Kumar Shukla (for both post), Ms. Sheetal Kumari W/o Sh. Narinder Mohan (for both Post), Ms. Romica D/o Sh. Ashok Kumar, Sh. Vishal Sharma S/o Sh. Sushil Sharma does not possess the necessary qualification and their applications have rejected and One form of candidate namely Ms. Amandeep Kaur D/o Manohar Singh for the post of General Counsellor was received after the last date fixed for receiving applications and the same is also rejected. So, total 22 applications are left.

Further scrutiny of applications revealed that some candidates have not attached required attested documents with the applications. Those candidates are given opportunity to complete the deficiencies and produce the requisite documents till 5.00 PM of 11.03.2024, in the office of District Legal Services Authority, Pathankot.

After due deliberations, the Committee has unanimously resolved that interview/interaction of the candidates shall be carried out in the post lunch session on **15.03.2024** at 2:15 PM onwards in V.C. Room, District Court Complex Pathankot.

System Officer be directed to upload the list of candidates who failed to produce requisite documents and to also upload the date to complete the deficiencies of documents on the website and they must be informed telephonically also.
