## Terms and conditions for the auction of one Photostat Shop, on lease at New Judicial Court Complex, Pathankot for the period from 01.07.2024 to 31.03.2025.

- That sealed applications of the eligible contenders should reach upto 24.06.2024 till 11:00 AM.
- 2. That the lease period shall be from 01.7.2024 to 31.03.2025.
- 3. That the auction proceedings shall take place on 25.06.2024 at 1:00 PM.
- 4. That the successful bidder shall have to deposit 25% of the lease money at the time of auction and balance amount shall be deposited within one month of the commencement of the lease period.
- 5. That in case of non-deposit of lease money within the prescribed time, the first deposit of 25% of lease money shall be forfeited and enclosures shall be put to auction for the remaining period. The first lessee shall be liable to pay the difference, if any, between the lease money, if the subsequent lease is for lesser amount.
- 6. That an amount of Rs. 5,000/- is required to be deposited as security, which is refundable at the end of financial year, subject to clearance of all dues.
- 7. That the allotment of premises/shop/space allotted shall be non transferable.
