In continuation to this Office Circular No.02 of 2022 dated 13.01.2022 and in accordance to the order of the Hon'ble Supreme Court of India and the letter of Hon'ble High Court of Gujarat cited in the preamble at Sr. Nos.(1), (2) & (4) respectively, the undersigned is pleased to inform that the Motor Accident Claims Tribunals of City Civil & Sessions Court at Ahmedabad, has newly opened Current Account from which the RTGS or NEFT transaction will be done in upcoming days.

Moreover, the Insurance Companies, Ahmedabad Municipal Transport Service (AMTS) and State Transport Corporation are hereby directed to instruct their banks to ensure deposits of amounts Awarded by the MAC Tribunals by way of Direct Bank Transfer to the below mentioned Current Bank Account of Claim Tribunals.
