- (1) New admission of the proceedings / cases filed under the Protection of Children from Sexual Offences Act, 2012 shall be as per this order.
- (2) From the date of effect of this order, all the proceedings i.e. production reports, bail applications, remand applications, etc. and cases filed under the POCSO Act 2012 shall be presented by the Criminal-I Department before the designated Courts as specified in this order.
- (3) Criminal-I Department is hereby directed to comply with this order forthwith. The Head of Criminal-I Department shall immediately send all the POCSO matters (including all the cases, applications, etc. pertaining to the POCSO Act, 2012) pending in any of the above Courts & the department to the concerned courts as per the police stations classified against the respective Courts mentioned in the aforesaid table.
- (4) The Head of the Computer Centre also, is hereby directed to transfer the concerned POCSO & Criminal Miscellaneous Applications, other applications, etc. in the CIS module of the City Civil & Sessions Court, Ahmedabad with immediate effect.
- (5) The Special Courts designated in Column No. (2) shall make sincere endeavor to see that the cases allotted to them gets disposed of on merits expeditiously in accordance with law & within the time frame under the provisions of the Protection of Children from Sexual Offences Act, 2012.
- (6) The Special Designated Courts shall also ensure with regard to the compliance of the directions passed by the Hon'ble High Court of Gujarat in the matters which are time bound.
- (7) The Head of Criminal-I Department is also hereby directed that if the production with regard to POCSO matters, etc is to be made on any of the non-working Saturdays or on Sundays or on any of the public holidays then he with the other staff members of Criminal-I Department should co-ordinate & mutually understand as to keep that particular staff member present at the time of production before the respective Judge in whose Court the production of the said matter is likely to be effected. The concerned attendant staff of all the above referred Special Courts, shall discharge their respective duty as and when required on non-working days & holidays, on which production is effected before the Court.

It is also hereby directed that, if there are more than one production on any of the non-working days then in that case all the productions for that particular day have to be effected together at the time so fixed by the Head of the Criminal-I Department in consultation with the respective Judicial Officer of that particular Court, same productions to be effected in dire need.
