- (3) Criminal-I Department is hereby directed to comply with this order forthwith.

 The Head of Criminal-I Department shall immediately send all the POCSO matters (including all the cases, applications, etc. pertaining to the POCSO Act, 2012) pending in any of the above Courts & the department to the concerned courts as per the police stations classified against the respective Courts mentioned in the aforesaid table.
- (4) The Head of the Computer Centre also, is hereby directed to transfer the concerned POCSO & Criminal Miscellaneous Applications, other applications, etc. in the CIS module of the City Civil & Sessions Court, Ahmedabad with immediate effect.
- (5) The Special Courts designated in Column No. (2) shall make sincere endeavor to see that the cases allotted to them gets disposed of on merits expeditiously in accordance with law & within the time frame under the provisions of the Protection of Children from Sexual Offences Act, 2012.

(6) The Special Designated Courts shall also ensure with regard to the compliance of the directions passed by the Hon'ble High Court of Gujarat in the matters which are time bound.
