Note:-

- 1) The Hon'ble Judges who have been allotted matters whether civil or criminal, in the previous business or the business in force as on today, should not send back those matters to the department or for disbursement to any other Court and they shall retain the same with them till final disposal of the matter irrespective of change in their respective business vide the present Office Order. Over and above, the following matters should not be sent back irrespective of the fact whether the business regarding these matters remains with the concerned Court:-
 - (a) High Court time-limit matters and direction matters.
 - (b) Sessions Cases in which charge has been framed, meaning thereby that the trial has commenced.
 - (c) Matters which are pending for delivery of final judgment/order.
 - (d) Specially assigned matters.
- 2) The Hon'ble Judges holding Chamber business, Auxiliary Chamber business and Bail matters as per this roster, shall retain with them all the pending matters of their respective courts and it should be their endeavour to decide the part-heard matters, the matters awaiting orders and judgments during their respective business as per this roster.
- Insofar as Bail matters are concerned, all the bail applications filed in the same C.R. number whether successive or by co-accused, be dealt with by the same Hon'ble Judge who has earlier decided the bail application of that accused or of the co-accused, so far as that Hon'ble Judge is available. Moreover, any application seeking modification in the bail order or conditions attached thereto and any application seeking cancellation of bail, be also dealt with by the same Hon'ble Judge who has earlier decided the bail application of that accused, if the same Hon'ble Judge is available.
- 4) So far as POCSO Courts are concerned, such Court or Courts, irrespective of change in business as per the present Notification, shall retain all such matters which are either at the stage of final arguments or final judgment/orders, for being accordingly disposed of by such concerned Court or Courts.

- As far as Commercial Courts are concerned, in case of filing of group matters, such matters/cases be allotted to and placed before the same Commercial Court in which the main matter/case is or is to be allotted in terms of the present Notification (Court Business).
- 6) Insofar as Sessions Cases are concerned, as and when cross cases or supplementary chargesheets are committed, the same shall by default be allotted to the Court in which the main case is pending/allotted.
