

**OFFICE OF THE DISTRICT & SESSIONS JUDGE, BATHINDA****ORDER**

In pursuance of Hon'ble High Court letters no.949/Spl./Gaz.II.(12G) dated 08.05.2023, and 1237 Spl.Gaz.II (12-G) dated 04.05.2013, the Courts will be closed for summer vacation for Civil Work (except urgent matters) from June, 01<sup>st</sup> 2023 to June, 30<sup>th</sup> 2023 (both days inclusive). However, there will be regular criminal work from 1<sup>st</sup> June to 15<sup>th</sup> June 2023 and from 16<sup>th</sup> June to 30<sup>th</sup> June, 2023, there shall be no work period in the Subordinate Court (except urgent matters) and Courts shall resume normal functioning for Civil and Criminal work w.e.f. 1<sup>st</sup> July, 2023 itself.

The urgent Civil and Criminal work of the Courts of Civil Judges shall be dealt with during the summer vacation w.e.f. 01.06.2023 to 30.06.2023 by the Officers on duty. However, remaining Judicial Officers (Civil Judges) of this Sessions Division shall avail summer vacation from 16.06.2023 to 30.06.2023.
