It is further informed to all the concerned that the Computer Proficiency Test for the said posts will be held as per following schedule:-

Important instructions for candidates:-

1. Candidates are required to reach the venue by 9:00 A.M. on 15.09.2024.
2. Candidates must bring atleast one original photo identity proof viz Aadhar Card/ Driving License/ Passport/ PAN Card etc.
3. Only one original identity proof and Pen is permitted inside the examination room. Further, Mobile Phone and Other Electronic items are not permitted inside the examination room.
4. Candidates are advised not to carry any valuable items like Mobile Phone, Smart Watch etc., as no arrangement will be there for safe keeping of such articles.
5. The Computer Proficiency Test (CPT) is to access the proficiency of candidates in operation of computer, which is mandatory but the marks of this Computer Proficiency Test would not be counted towards the final merit as this test will be only of qualifying in nature.
6. It is expressly made clear that appearance of the candidate for the Computer Proficiency Test is purely provisional and subject to fulfilling the prescribed eligibility conditions during or after the selection process, failing which his/her candidature shall stand cancelled and if appointed erroneously such candidate shall be removed from service.
7. No separate letters/ roll numbers/ admit cards regarding Computer Proficiency Test for the post of Clerk (on adhoc basis) will be sent to candidates.
