Learned members of the Bar or the petitioner/respondent appearing in person who desires hearing of any urgent matter through video conferencing are required to follow the procedure prescribed under:

- 1. Vidyo Desktop/Vidyo Mobile application is to be downloaded on personal desktop/laptop/mobile device.
- For linux/ubuntu by clicking download link as available on http://ecourtvc.nic.in
- 3. Google Play Store (https://play.google.com/store/apps/details? id=com.vidyo.VidyoClient&hl=en) for android devices.
- 4. Apple Store for iOS devices (https://apps.apple.com/us/app/vidyomobile/id444062464).
- 5. A link will be sent to the learned Advocate or the petitioner/respondent appearing in person by text message, whatsapp message or by e-mail to join the video conferencing room through Vidyo Desktop/Vidyo Mobile application.

- 6. 4. On receipt of text message/whatsapp message or e-mail, learned Advocate or the petitioner/respondent appearing in person may join the video conferencing session clicking on the said link. If the Vidyo Desktop/ Mobile application has not been installed, the said link will automatically install the application.
- 7. Learned Advocate or the petitioner/respondent appearing in person to whom the link is sent shall ensure that the link is not shared with others, not connected with the matter.
