In addition to the holidays notified above, Government Employees may avail of maximum of any two of the holidays on the festival occasions at their option and irrespective of their religious denomination, out of list of the optional holidays declared for the year - 2025. Permission for availment of this optional holidays should however, be applied for in advance and will normally be granted by the officer competent to grant Casual Leave with due regard to the exigencies of Government Work. This leave of two days taken by the Government Employees at their discretion on the festival of their choice will not be debited on their Casual Leave account.
