Sub: Recruitment to the post of Typist and Typist-Copyist-reg.

Ref.: 1. This office Notification No. ADM/16/2023, dated: 20.12.2023.

This office has invited applications, through online for the post of Typist and Typist-Copyist vide Notification cited under reference No.01, In the said Notification maximum age limit was fixed as 35 years for General Merit candidates, 38 years for Category-2A, 2B, 3A and 3B candidates and 40 years for SC, ST and Cat-I candidates.

As per G.O.No. SIAaSuE 166 SeNeNi 2024 dated: 10.09.2024, it is ordered that the maximum age limit is relaxed/extended by three (3) years to all category candidates, as a one time measure.

In view of the above G.O., maximum age limit fixed for the post of Typist and Typist-Copyist in notification cited under reference No.01 is modified as under:

| Category | Maximum Age | Remarks |
|-----------------|--------------------|--|
| General Merit | 38 Years | Only Candidates who have crossed the age of 35 years as on 22.01.2024 are eligible for relaxation and shall apply. |

| 2A, 2B, 3A & 3B | 41 Years | Only Candidates who have crossed the age of 38 years as on 22.01.2024 are eligible for relaxation and shall apply. |
| SC, ST & Cat-I | 43 Years | Only Candidates who have crossed the age of 40 years as on 22.01.2024 are eligible for relaxation and shall apply. |

Accordingly, 3 years age relaxation in the maximum age limit is provided in respect of all category candidates. The candidates, who were ineligible to submit application due to crossing the maximum age limit as on 22.01.2024 as per the notification dated: 20.12.2023 are now eligible due to age relaxation and they can submit their application through online from 13.01.2025 to 11:59 PM on 27.01.2025 through the link <https://ramanagara.dcourts.gov.in/online-recruitment/>. Last date for payment of fee will be 11:25 PM on 28.01.2025. The candidates should be within the extended maximum age limit prescribed for the respective category as on the last date of submission of application i.e., 22.01.2024 stipulated in the Notification dated: 20.12.2023.

Except maximum age limit, all other conditions, information, instructions contained in the Notification dated: 20.12.2023 shall remain unaltered. Candidates shall read the said Notification dated: 20.12.2023 cited under reference No. 01, for further details.
