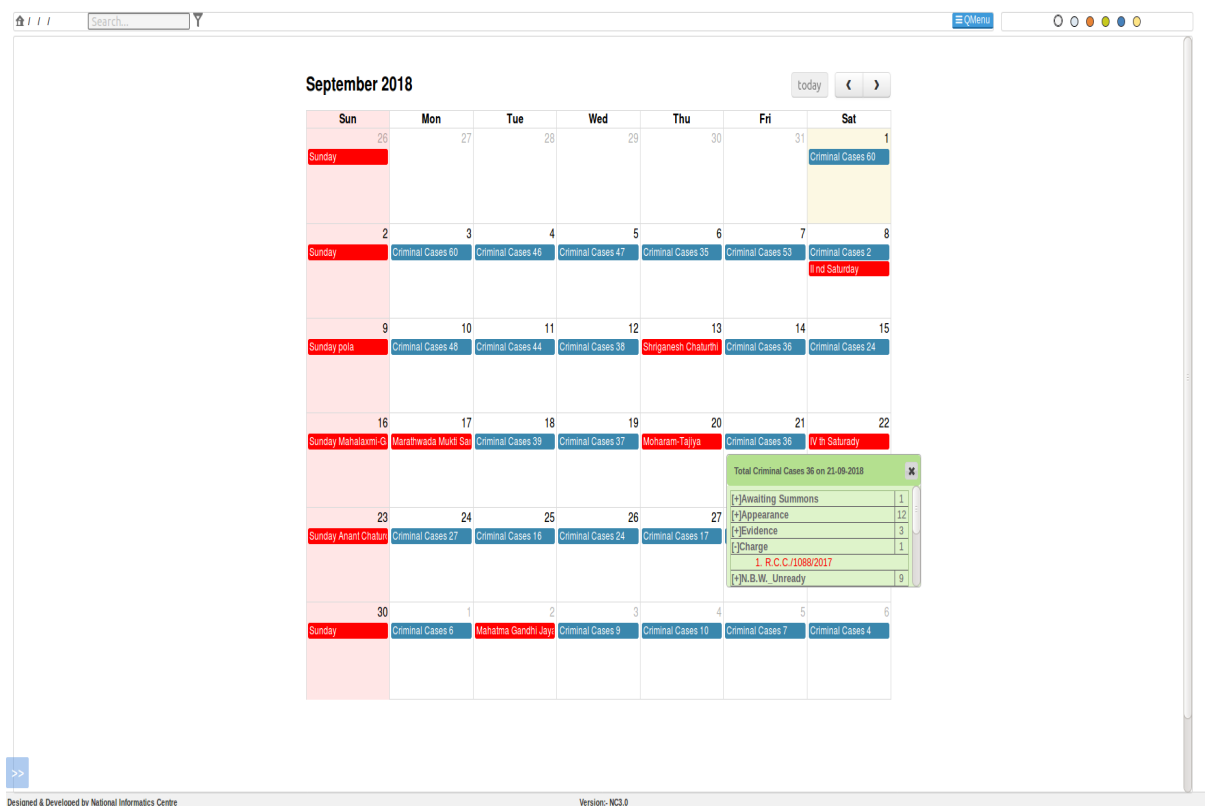
•Calender Option in CIS 3.0

Calender Option is available in the Qmenu of the CIS NC 3.0. It is one of the best Management Tools available for Judges. It shows number of cases listed on a particular date and provides for detailed Hearing Schedule of the listed cases.

The Calender Option helps Judges to manage their work while assigning next dates to the cases on the Daily Cause List.

The figures of Cases can be further clicked to view stage wise cases listed. On clicking the Stage, a list of all the cases listed on that stage is displayed.

Calender option is a virtual diary for Judges and can be used for Portfolio Management.

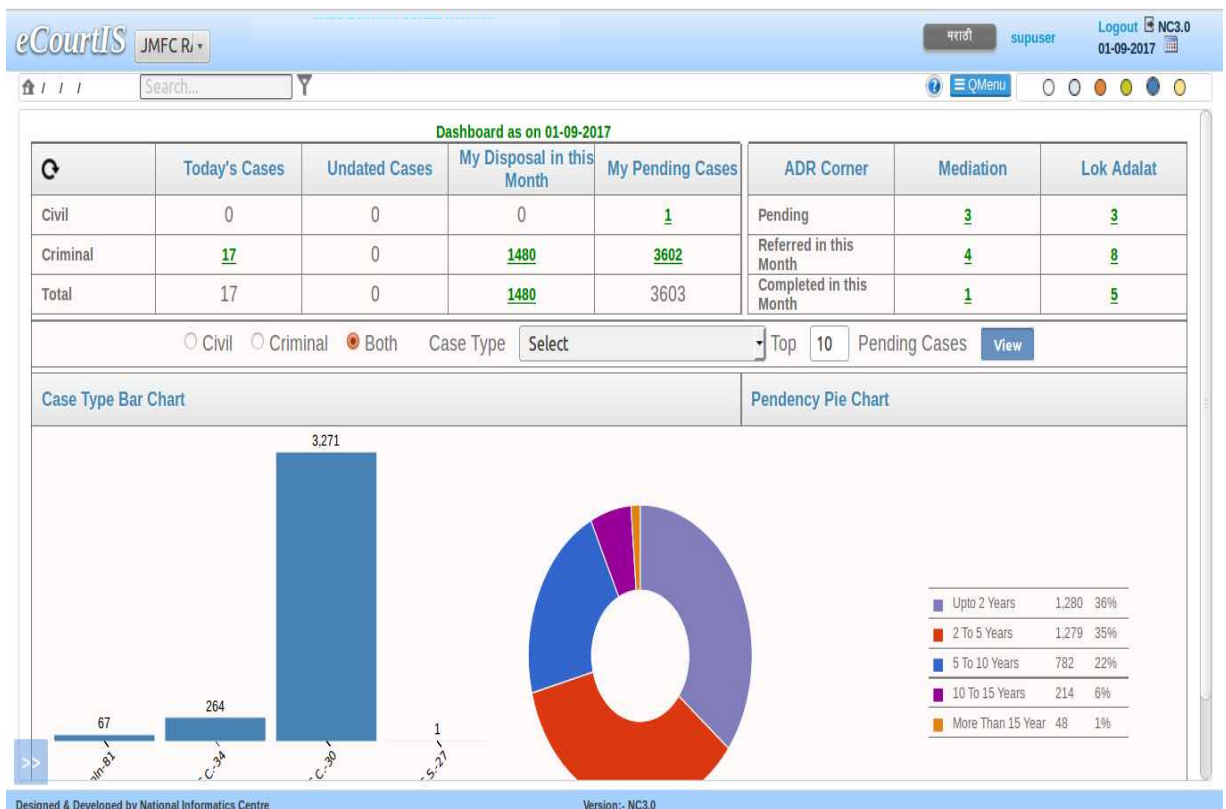

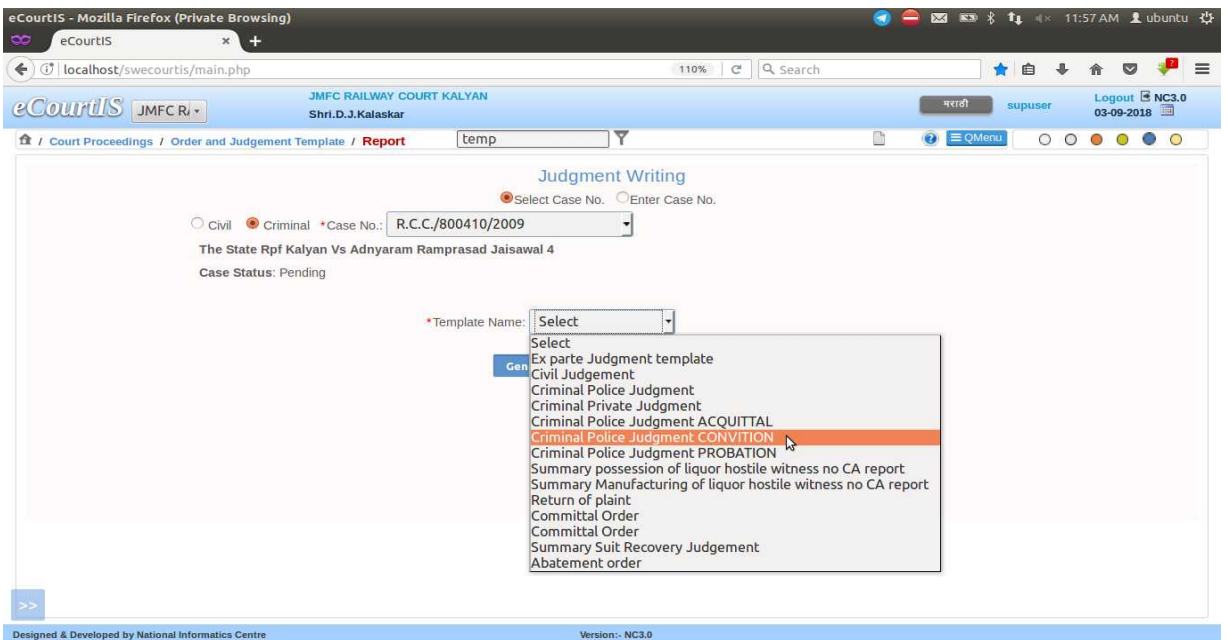
