#### 1. What are Legal Services?

Legal Services Includes providing Free Legal Aid to those weaker sections of the society who fall within the purview of section 12 of the Legal Services Authority Act 1987. It also entails creating legal awareness by spreading legal literacy through legal awareness camps, print and digital media and organizing Lok Adalats for the amicable settlement of disputes which are either pending or which are yet to be filed. Legal services also helps in facilitating the beneficiaries to get their entitlements under various government schemes and policies.

#### 2. Who is Entitled to Free Legal Services?

The sections of the society as enlisted under Sections 12 of the Legal Services Authorities Act are entitled for free legal services, they are;

(a) A member of a Scheduled Caste or Scheduled Tribe;

(b) A victim of trafficking in human beings or beggar as referred to in Article 23 of the Constitution;

(c) A women or a child;

(d) A person with disability as defined in Cl.(1)of Sec.2 of the Persons with disabilities (equal opportunities Protection of Rights and Full Participation) Act, 1995

(e) A person under circumstances of undeserved want such as being a victim of a mass disaster, ethnic violence, caste atrocity, flood, drought, earthquake or industrial disaster; or

(f) An industrial workman; or

(g) In custody, including custody in a protective home within the meaning of clause (g) of section 2 of the Immoral Traffic (Prevention) Act 1956 (104 of 1956); or in a juvenile home within the meaning of clause (j) of Section 2 of the Juvenile Justice Act, 1986 (53 of 1986); or in a psychiatric hospital or psychiatric nursing home within the meaning of clause (g) of Section 2 of the Mental Health Act, 1987(14 of 1987); or

(h) A person in receipt of annual income less than 3,00,000/- p.a., or such higher amount as may be prescribed by the State Government if the case is before a Court other than the Supreme Court, and less than Rs. 5,00,000/- or such other higher amount as may be prescribed by the Central Government, if the case is before the Supreme Court.
