Sub: MIGRATION OF DATA TO CISCO WEBEX LICENCE-ENTERPRISE VERSION.

Sir/Madam,

Reference is invited to the subject matter. This is to inform you that in terms of decision of Centralized Computer Committee and approval of learned Principal District & Sessions Judge (HQs), the Delhi District Courts are going to migrate to the Enterprise Version of CISCO WebEx from 01.01.2021.

It may be noted that though the **existing user id and password will remain same** after migrating to the Enterprise Version of CISCO WebEx, but the meeting recordings, if any, stored in the cloud storage of the Cisco Webex app (currently used by the courts) will be lost. Accordingly, all the users are requested to download the existing data of recordings, if any, as per the procedure explained in the annexed documents preferably by 31.12.2020 and back-up thereof be created accordingly.
