CIRCULAR

In view of spurt in Coronavirus (Covid-19) cases, a special drive for conducting the RT-PCR tesis for all the staff posted at Karkardooma Courts Complex, Delhi shall be started w.e.f. 17.09.2020 from 2:00 PM to 3:00 PM in the DGHS Dispensary, Karkardooma Courts Complex. objective to contain the spread of Covid-19 pandemic and to facilitate the staff, the following arrangements have been made:

- 1. All the Nodal Officers, East/Shahdara/North-East District, who are appointed to facilitate the staff in getting the treatment of Covid-19 in case of emergency, in consultation with their respective Administration Branch, shall prepare a list, comprising of full details of staff, posted in each District.
- The Nodal Officers in coordination with each other, further make a consolidated proposed list of 25-30 staff members for RT-PCR Test, one day in advance and submit the same to CMO/In-charge, DGHS Dispensary, Karkardooma Courts, Delhi. For example – if the test is to be conducted on 15/09/2020, the Nodal Officer, East, Shahdara & North East shall make a consolidated proposed list of 30 staff members (10 from each district) on 14/09/2020 and shall submit the same to the CMO. Copy of such list shall be retained by the concerned Nodal
- 3. The Nodal Officers shall coordinate the CMO/In-charge, DGHS Dispensary regarding the prerequisite formalities for test and the time slot to be given to each and every member of staff for test, in order to avoid over- crowding and maintain social-distancing in dispensary.
- 4. No staff member shall be allowed to collect his/her report from dispensary. The Nodal Officers shall collect the medical reports of all the staff on their behalf and intimate/send the same to the concerned person through WhatsApp or email.

5. The Nodal Officers shall maintain a record in this regard and in case of any covid-19 contagion positive case, they shall immediately inform their respective Administration Branch.
