CORRIGENDUM

No. 61(313) DD (CPU)/DWCD 2013/Vol.III/28784-816 dated 25.10.2018 of Govt. of NCT of Delhi, specified the Court of ASJ-06, East District, Karkardooma Courts, as designated Court to deal exclusively with the cases relating to trial of offences against children or of violation of Child right for the National Capital Territory of Delhi in addition to already notified Court to Additional Sessions Judge-01.
